

## **"Christmas Special: Little Monster e-Lab" Mobile Treasure Hunt for Lee Gardens Club Members - Terms and Conditions**

1. From 2 December 2022 – 2 January 2023, participants can open the Lee Gardens App to enter the "Christmas Special: Little Monster e-Lab" Mobile Treasure Hunt campaign site.
2. Only Lee Gardens Club members are eligible to participate in this promotion. Participants are required to log in as a Lee Gardens Club Member on the campaign site to join the game. Non-members who attempt to participate in this promotion are required to register as a Lee Gardens Club member by clicking "Register" to create an account.
3. Participants are required to confirm the acceptance of the terms and conditions of this promotion and click "Start the Challenge" to proceed.
4. Participants are required to collect three elements for each little monster by scanning a specified QR code in designated locations (Lee Garden One - Three, Hysan Place and Lee Theatre Plaza). Upon completion of the game, participants will receive a complimentary gift for every single monster created.
