PLAYDOT ENTRY REQUIREMENTS & REGULATIONS

- 1. Please comply with all instructions as issued from time to time by Hysan Marketing Services Limited ("Hysan") and/or Property Manager of Lee Garden Two.
- 2. The play facilities of Playdot are designed for children <u>under 12 years old</u>. Children must be accompanied by an adult aged 18 years old or above.
- 3. For the safety of you and your children, you must comply with all signage, notices, and all directions and requests of our staff to avoid injury. Each child must be under the adult attendant's constant and close supervision during his/her time at Playdot. All attendees enter and use Playdot at their own risk. Hysan and/or Playdot is not liable for any injury, loss or damage however caused in Playdot.
- 4. Adults should educate and restrict the accompanied children from performing aggressive or inappropriate behaviours including but not limited to running, turning somersaults, jumping off from the facilities, pushing, hitting others, throwing any objects, littering or violating any other rules and regulations.
- 5. If you or your accompanied children have any special medical conditions, please consult medical professions about the suitability in using any equipment or facility in Playdot before your admission. Please notify our staff immediately when you require any assistance.
- 6. For the safety and hygiene, all persons entering Playdot shall keep their shoes in designated cabinet. Adults must wear socks and children must wear anti-slip socks while enjoying the facilities.
- 7. Lockers are provided as a temporary storage in our area, please mind your own belongings at all times. Hysan and/or Playdot will not be held liable for any lost, stolen, or damaged personal property and belonging brought into our premises.
- 8. No sharp or dangerous objects are allowed in Playdot.
- 9. No outside drinks and food are allowed to be brought into Playdot except for milk, water, medicine, or other items with the prior approval of our staff.
- 10. No pets are allowed (except guide dogs) in the premises.
- 11. No smoking is allowed in the premises.
- 12. No photography, videotaping, recording of any kind, broadcast or transmission for commercial purposes is allowed in the premises.
- 13. All entry tickets are non-refundable and non-exchangeable.
- 14. Limited quota available per session while stocks last.
- 15. Hysan and/or Playdot may from time to time without prior notice and without refund or compensation, change the operating hours, close Playdot or any part of it temporarily, restrict the number of persons having entry access, and suspend or cancel any facility, due to the reasons of capacity, inclement weather, special events, or if we consider that the circumstances so require to ensure the safety, security or order.
- 16. Playdot will be closed if the Black Rainstorm Warning Signal or Tropical Cyclone Warning Signal No. 8 or above

is in force 3 hours before Playdot opening hours.

- 17. Playdot programmes and workshops will be cancelled if any of the following signals is issued and still in force 3 hours before the activity is scheduled to begin: Tropical Cyclone Warning Signal No. 3 or above; Black Rainstorm Warning Signal; or Red Rainstorm Warning Signal.
- 18. Please keep the place clean and follow our regulations, Hysan and/or Playdot reserves the right to charge individuals for the cleaning fee or the cost of rectifying damage which has been caused by improper use of facilities.
- 19. In the event of any disputes, Hysan and/or Playdot reserves the right of final decision.
